

Dried Yeast



Product Description

PRO-DY is a cost-competitive, palatable, high-quality source of digestible amino acids from a yeast-based protein. It consists of dried, inactive (killed) yeast (*Saccharomyces cerevisiae*). PRO-DY yields economic and nutritional benefits to swine, poultry, and aquaculture.

Features

- No known anti-nutritional factors make it suitable for use in swine nursery diets
- Consistent quality and supply; improves return-on-investment by displacing protein sources that are more variable in quality, supply, and price
- Highly concentrated yeast with no added carriers, thereby adding flexibility to the ration formulation due to lower inclusion rates to achieve targeted levels of critical amino acids and complements many other protein sources

Usage Rate

For further manufacture of animal feeds. This product is intended as a source of protein for making animal feeds. Contact your ADM representative for usage rate tailored to your specific farm conditions.

- **Swine:** Has been successfully used in nursery diets during the first six weeks post-weaning at up to 8% of the diet. Nursery pig feed efficiency also benefited with inclusion of PRO-DY in the diet.
- **Poultry:** Can be included up to 10% of the diet for poultry with no detriment to performance, allowing a wide range of formulation opportunities.
- **Aquaculture:** Has been shown to successfully replace other protein sources, such as fishmeal, in diets of fish and shrimp. Amount of PRO-DY to use in aquaculture diets depends on species type. Consult with your nutritionist.

Store in unopened, original packaging in cool, dry area. Shelf life is two years from date of manufacture.
